## ARTICLES OF ASSOCIATION

### PART I

#### FORM, NAME, REGISTERED OFFICE, PURPOSE, TERM

**Article 1** The Company is a Belgian public limited company (*société anonyme*). The name of the Company is “Ion Beam Applications”, abbreviated to “IBA”.

**Article 2** The registered office of the Company is established in the Walloon Region.

**Article 3** The Company has as its purpose the research, development and acquisition of industrial property rights, with a view to the operation, manufacture and marketing of applications and equipment in the field of applied physics.

It may carry out all financial, commercial and industrial transactions and transactions involving moveable property and real estate relating directly or indirectly to its purpose.

It may acquire an interest, by way of contribution, merger, subscription or in any other way, in all businesses, joint ventures or companies having a purpose that is similar, analogous or related to or useful for the achievement of all or part of its purpose.

The Company’s objectives include having, in the conduct of its business, a positive material impact on all of its stakeholders, in particular, patients, shareholders, employees, customers, society and the planet.

The Company is managed by taking into account the interests of these stakeholders, with respect for life and for current and future generations, and by minimising any negative environmental and societal impacts.

**Article 4** The Company, which was incorporated on 28 March 1986, has an unlimited term.

### PART II

#### SHARE CAPITAL, SHARES

**Article 5** The share capital is set at forty-two million, five hundred and two thousand, three hundred and eighteen euros and fifty-four cents (€42,502,318.54).

It is represented by thirty million, two hundred and eighty-two thousand, two hundred and eighteen (30,282,218) shares with no par value, each representing one/thirty million, two hundred and eighty-two thousand, two hundred and eighteenth part (30,282,218<sup>th</sup>) of the share capital.

#### Subscription rights

There are currently twenty thousand (20,000) subscription rights, hereinafter referred to as warrants, issued by the board of directors on 18 December 2015, with the exercise of one (1) warrant enabling the subscription of one (1) new share. The deadline for the exercise of these warrants is 31 July 2024.

**Article 6** The board of directors has the power to increase the share capital of the Company, to issue convertible bonds or subscription rights, in one or more transactions, within the limits regarding caps and periods imposed by law.

The board of directors is expressly authorised, for a period of three years, to use this power in those cases referred to in Articles 7:200 (limitation or cancellation of the preferential right and incorporation of reserves) and 7:202 (notice of a takeover bid) of the Belgian Code on Companies

and Associations (CSA).

**Article 7** Payments to be made on shares not yet fully paid up shall be made at such place and date as determined by the board of directors.

Amounts called and not paid within eight days of their due date shall bear interest, calculated per day of delay from the due date, at the rate applicable to the largest bank lending facility contracted by the company and in force as of such date.

The board of directors may also, after a formal notice sent by registered letter and having remained without effect for one month, declare the forfeiture of the shareholder and sell those shares for which the called payments have not been made. The net proceeds of the sale shall first be charged by the Company against the amounts owing thereto as principal and interest by the defaulting shareholder, without prejudice to the right of the Company to claim the outstanding amount from such shareholder as well as any potential damages. The surplus, if any, shall be remitted to the defaulting shareholder if not otherwise a debtor of the Company.

**Article 8** Shares shall remain in registered form until they have been paid up in full.

Fully paid-up shares and other securities issued by the company are in registered or dematerialised form, at the choice of the shareholder.

Owners of securities may request the conversion of their securities into the other form, at their own expense.

**Article 9** The Company may, without further decision of the general meeting, acquire its own shares, profit shares or certificates, in accordance with the conditions set by law (Articles 7:215 *et seq.* of the Belgian Code on Companies and Associations) in one or more transactions, up to a maximum of twenty percent (20%) of the total number of securities concerned issued, for a minimum equivalent value of ten cents (EUR 0.10) and a maximum equivalent value of twenty percent (20%) above the most recent stock market price. This authorisation is granted for a renewable period of five years starting on the date of publication of this authorisation under the articles of association (or its renewal).

The Company may dispose of the securities thus acquired in accordance with the conditions set by law (Article 7:218, §1, of the Belgian Code on Companies and Associations), including in the cases referred to in 3) and 4) of Article 7:218, §1, paragraph 1, of the Belgian Code on Companies and Associations.

In addition, in accordance with Article 7:215, §1, paragraphs 4 and 5, and Article 7:218, §1, paragraph 1, 3), of the Belgian Code on Companies and Associations, the Company may, without any other resolution by the general meeting being required, in accordance with the conditions set out in these provisions, in particular as to duration (being a period of three years beginning on the date of publication of this authorisation via the articles of association or its renewal), make use of this power and acquire or dispose of any treasury securities, via the market on which such securities are listed or in any other manner, in order to avoid serious and present harm thereto.

### **PART III** **ADMINISTRATION, AUDIT**

**Article 10** In their decision-making, the directors shall, in particular, take into account the social, economic, legal, ethical or other consequences of the Company's business with respect to (i) patients, (ii) clients of the Company and its subsidiaries, (iii) its shareholders, (iv) employees,

subsidiaries and suppliers, (v) the communities and society in which the Company, its subsidiaries and suppliers are operating, (vi) the local and global environment and (vii) the short and long-term interests of the Company. The “IBA Foundation” (private foundation registered in the Walloon Brabant Register of Legal Entities under no. 0803.901.356) was established to ensure the proper application of these principles. To this end, and without this affecting the equilibrium described in Article 12, one third of the members of the board of directors must, at all times during its existence, be elected further to a proposal from the “IBA Foundation”.

**Article 11** The Company is managed by a board of directors composed of a minimum of three members and a maximum of twelve members, appointed by the general meeting for a renewable term not exceeding the term defined by law.

**Article 12** The composition of the board of directors must at all times reflect the equilibrium imposed by law as well as the following equilibrium:

- (a) at least one third of its members (hereinafter referred to as “**independent directors**”) must be independent directors, chosen for their experience, discernment and personality, and who meet the definition set out in Article 7:87 of the Belgian Code on Companies and Associations;
- (b) at least one third of its members (hereinafter referred to as “**internal directors**”) must be elected further to a proposal from the managing director(s);
- (c) the other directors (hereinafter referred to as “**other directors**”) are appointed without restriction by the general meeting, provided however that, among these other directors, there can be no more than two members who are “*directly or indirectly related to the same shareholder*” (or to a company or individual related thereto) within the meaning of paragraph 2 of this Article 12; and
- (d) up to one third of its members have been elected further to a proposal by or via the decisive vote of an institutional private investor or group of institutional private investors; and
- (e) up to one third of its members may be “*directly or indirectly related to a shareholder*” or group of shareholders (or to a company or individual related thereto) within the meaning of paragraph 2 of this Article 12, where such shareholder (or group of shareholders):
  - (i) either directly or indirectly conducts business in one or more business sectors in which the Company or one of its subsidiaries is also active;
  - (ii) holds more than forty percent (40%) of the securities with voting rights attached issued by the Company.

For the purposes of this Article 12, paragraph 1, (c), (d) and (e), a director (natural person or legal entity) is considered as being “*directly or indirectly related to a shareholder*”, when such director:

- (a) is, or during the five years preceding the appointment has been, a member of the administrative or management bodies, or the staff, of this shareholder (or of a company related thereto) or has received a power of attorney from the latter;
- (b) has, with this shareholder (or a company or individual related thereto) or with a person or entity referred to in (a), business, shareholding or family relations likely to influence the conditions under which he/she performs his/her duties as director; or
- (c) has been appointed on the proposal or by the decisive vote of such shareholder.

For the application of this Article 12, the concept of company or person “*related*” to another shall be understood within the meaning of Article 1:20,1) and 2) of the Belgian Code on Companies and Associations.

Proposals for the appointment of “independent directors” and “other directors” are presented by the appointments committee set up within the board of directors. This committee is composed of five members, including three internal directors and two independent directors. In addition, none of the directors defined in paragraph 1, (d) of this Article 12 may sit on this committee, unless, where applicable, they are otherwise internal directors.

Proposals for the appointment of “internal directors” are presented by the director(s) responsible for day-to-day management who must communicate to the board of directors the names of the candidates to be submitted to the general meeting.

No director may be appointed on the proposal of one or more shareholders if this proposal, containing all the information as to the person of the proposed director necessary in particular to enable the verification of compliance with the equilibrium provided for in this Article 12, has not been communicated to the board of directors within the deadlines set by law.

Any proposal for the appointment of a director submitted to the general meeting must state whether the proposed individual is to be considered an “independent director”, an “internal director” or a “director directly or indirectly related to a shareholder” within the meaning of this Article 12.

If the general meeting does not vote in favour of the proposals presented thereto in accordance with the preceding paragraphs, new proposals shall be formulated by following the same procedure and the general meeting shall be convened again in order to decide on the new proposals.

**Article 13** The effects of the resignation, dismissal or expiry of a director’s term of office shall be suspended for as long as this would have the effect of upsetting the equilibrium provided for in Article 12. Consequently, any director who resigns, is dismissed or whose term of office has expired, shall, where applicable, continue to perform his/her duties until this equilibrium has been re-established.

The board of directors may provisionally fill vacancies for directorships, in accordance with the equilibrium and proposal procedures described in Article 12.

**Article 14** The board of directors chooses a **chairman** and, where applicable, a vice-chairman, from among its members. Unless the board of directors unanimously decides otherwise, the chairman and the vice-chairman may not be one of the directors referred to in Article 12, paragraph 1, (d).

In the absence of the chairman, his/her duties are performed by the vice-chairman or, failing this, by the oldest director.

**Article 15** With regard to remuneration, the Company may agree an exception to Article 7:91, paragraphs 1 and 2, of the Belgian Code on Companies and Associations (shares, stock options and variable remuneration).

**Article 16** Without prejudice to unanimous decisions taken in writing, the board of directors shall meet whenever the interests of the Company so require and whenever requested by at least two of the directors.

Meetings are convened by the chairman or, in his/her absence, by the vice-chairman or the oldest

of the directors.

The notice of meeting is sent to the directors via email, fax or simple letter at least three days ahead of the date of the meeting. The notice of meeting contains the agenda. In the event of urgency or with the unanimous agreement of the directors, the above conditions regarding calendar and formalities may be waived.

Meetings are held at the registered office of the Company or at the place indicated in the notice of meeting.

**Article 17** The board of directors has a quorum only if a majority of its members are present or represented. Its decisions are taken by a majority of the votes cast. In the event of a tie, the chairman (or his/her replacement) has the casting vote.

Any director may participate in the deliberations of the board by conference call or any other technical means allowing for effective deliberations between the members of the board; any director thus participating in the deliberations is deemed present.

Any director may grant another director a mandate in writing (including email and fax) to act as his/her representative at a specific meeting of the board of directors and to vote on his/her behalf at such meeting.

**Article 18** The minutes of the meetings of the board of directors are signed by the chairman and any directors upon request. Copies and extracts to be issued to third parties are signed by a managing director or by two directors.

**Article 19** Without prejudice to the more restrictive conflict of interest provisions of the Belgian Code on Companies and Associations, the directors referred to in Article 12, paragraph 2, do not take part in any deliberations of the board of directors relating to a decision or transaction (a) in which the shareholder to which they are related within the meaning of this Article 12, paragraph 2, has a direct or indirect interest or (b) which may give rise to a direct or indirect financial benefit for such shareholder.

**Article 20** The board of directors creates the internal committees required by law, the composition and duties of which are governed by law.

**Article 21** The Company is represented in all privately executed or notarised deeds, including those involving a public official and in court, by two directors acting jointly, who will not be required to provide evidence of any prior decision by the board of directors, with regard to third parties. In the context of the day-to-day management, the Company is validly represented by an individual responsible for this management, given the title managing director if he/she is also a director.

It is also validly represented by special representatives within the limits of their mandate.

**Article 22** The audit of the Company is entrusted to one or more statutory auditors, whose method of appointment, term of office, duties and fees are governed by law.

#### **PART IV** **GENERAL MEETINGS**

**Article 23** The general meeting, duly convened, represents all of the shareholders.

It has the powers conferred thereupon by law.

General meetings, both ordinary and extraordinary, are held at the registered office of the



Company or at any other place in Belgium, as indicated in the notice of meeting.

**Article 24** The ordinary general meeting is automatically held at ten a.m. on the second Wednesday in June. If this day is a public holiday, the meeting takes place on the next working day, at the same time.

**Article 25** The mandatory rules of the Belgian Code on Companies and Associations govern the methods used to call general meetings, as well as the conditions of admission and the procedures for participation and representation at such meetings. Voting by proxy or via a postal vote is permitted in the forms set out in the notices of meeting. Voting by proxy or via a postal vote is permitted in the forms set out in the notices of meeting.

**Article 26** The general meeting is chaired by the chairman of the board of directors or, in his/her absence, by the vice-chairman of the board of directors or, failing that, by the oldest director.

The chairman appoints the secretary and the general meeting appoints two observers (*scrutateurs*).

**Article 27** No shareholder may, with companies and persons related thereto, participate in the voting at a general meeting for a number of votes exceeding thirty-five per cent (35%) of the votes attached to all the securities with voting rights issued by the Company.

In addition, provided that other shareholders unrelated thereto, individually holding at least fifteen per cent (15%) of the voting securities issued by the Company, participate in the general meeting, no shareholder may, together with the companies and persons related thereto, take part in the vote, for each resolution put to the vote, up to a number of securities exceeding half minus one of the securities admitted to the vote and expressed respectively for each resolution put to the vote.

For the application of the preceding paragraphs, the following are considered as being related to a shareholder:

- any company or individual related to such shareholder within the meaning of Article 1:20 of the Belgian Code on Companies and Associations;
- any natural person or legal entity forming part of the administrative or management bodies of such shareholder or of a company referred to in the preceding point;
- any third party acting in its own name and also on behalf of such shareholder or one of the individuals or entities referred to in the two preceding points;
- any shareholder who has given a power of attorney to this shareholder or to a person or entity referred to in the preceding points with a view to being represented at this general meeting.

**Article 28** Without prejudice to Article 27, shareholders who hold fully paid-up shares, registered for at least two years without interruption in their name in the register of registered shares and meeting the conditions imposed by law (Article 7:53 of the Belgian Code on Companies and Associations) benefit from the multiple voting right provided for by law for these shares in relation to other shares representing the percentage of the share capital.

**Article 29** Other than in those cases in which the law imposes other conditions of presence or majority, the general meeting is quorate and deliberates validly regardless of the fraction of the capital represented and decisions are taken on the basis of a simple majority of votes without

abstentions being taken in the numerator or denominator.

However, any amendments made to the following articles of the articles of association: Article 11, Article 12, Article 13, Article 14, Article 19, Article 27 and Article 29 may only be adopted provided that those attending the meeting represent one half of the share capital and that the proposed amendments represent at least eighty-five percent (85%) of the votes cast.

**PART V**  
**FINANCIAL YEAR, DISTRIBUTIONS**

**Article 30** The financial year begins on 1<sup>st</sup> January and ends on 31 December.

**Article 31** The board of directors is authorised to distribute an interim dividend to be deducted from the dividend to be distributed from the results for the current financial year, under the conditions provided for by law.

**PART VI**  
**DISSOLUTION, LIQUIDATION**

**Article 32** In the event of the dissolution of the Company for any reason and at any time whatsoever, the liquidation is carried out in accordance with the law by a liquidator (or a group of liquidators), the method of appointment and powers of which are governed by law.

The general meeting sets the emoluments of the liquidators.

**Article 33** After all debts, charges and liquidation costs have been settled, the net assets are used first to repay, in cash or in securities, the paid-up amount of the shares.

If the shares are not all paid up in equal proportion, the liquidators, before proceeding with the distributions, take account of these differing situations and restore the balance by placing all shares on an absolute equal footing, either by additional calls for funds for those securities not sufficiently paid up or by prior cash repayments in favour of the securities paid up in a higher proportion.

The balance is distributed equally between all of the shares.

**PART VII**  
**GENERAL PROVISIONS**

**Article 34** The mandatory provisions of the Belgian Code on Companies and Associations not reiterated in these articles of association apply automatically. In addition, the supplementary provisions of the Belgian Code on Companies and Associations not waived in these articles of association are deemed to be included in these articles of association.

**Article 35** In accordance with Article 18 of the Law of 2 May 2007 *on the disclosure of significant holdings in issuers whose shares are admitted to trading on a regulated market and containing various provisions*, the notification obligation set out in Articles 6 *et seq.* of this Law is applicable to the crossing, upwards or downwards, of any minimum percentage of one percent (1%), two percent (2%), three percent (3%), four percent (4%), five percent (5%), seven point five percent (7.5%), and to percentages of ten percent (10%), fifteen percent (15%) and so on in tranches of five percent (5%), of the total voting rights outstanding at the time of the occurrence of the situation giving rise to the declaration under this Law.
